From 2005 to 2011 he taught *Political Economy*. He is currently teaching *Theories and History of International Economic Relations*, and *History of Economic Thought* at the University of Roma Tre. He was member of several *National Research Projects* and *Academic Coordinator* of the *Jean Monnet + Project “UrEU”*; he holds a *Jean Monnet Chair* on *European Economic Governance*. Main fields of research: European and international economic and monetary integration; economic policy and public intervention in the economy; history of economic thought; the economics and policy of local development; the economics of tourism and local resources.
