It examined the dynamics of social exclusion and inclusion in Italy, with a particular focus on the geopolitical motivations behind migratory flows, including those stemming from war-torn areas and climate change.

(2) Educational Activities:

To complement the in-depth exploration of migration in Europe, students engaged in hands-on laboratory activities aimed at supporting the integration of young migrants and Romani children attending after-school programs in Rome's outskirts. These after-school programs serve as transformative educational experiences, fostering a new perspective on diversity, promoting empathy, rejecting violence, caring for the vulnerable, and instilling a belief in the power of action to transform situations of poverty and marginalization.

Project Founder and Director of "80 years from the Racial Laws / 70 years from the Universal Declaration of Human Rights: an educational project," carried out at the Department of Education of Roma Tre University involving 200 students from 4 high schools in Rome (Giulio Cesare, Tasso, Plinio, Montessori), through the realization of 4 thematic workshops, a documentary film review, and a plenary study day on the occasion of the commemoration of the signing of the Universal Declaration of Human Rights, 2018-2019:

Primary Focuses:

(1) Unveiling the Manipulation of Public Opinion and the Ethicization of the "Public Enemy" in Fascist Racial Colonialism and Antisemitism:

This research strand delved into the historical tactics employed by the Fascist regime to manipulate public opinion and construct an ethnically defined "public enemy" through propaganda campaigns. It drew comparative parallels with contemporary disinformation techniques disseminated through mass media and social networks.

(2) Unmasking Bias: Examining Media Narratives on Migration:

In collaboration with the "Carta di Roma Association", an organization established in 2011 to promote ethical journalism on immigration issues. Journalists and experts from the association conducted practical workshops for students, focusing on the relationship between media and international migrations. These workshops analyzed the dominant narratives surrounding immigrants and migrants presented by the press and new digital communication technologies.

Student-led Laboratory Exercises:

Culminating the project, students engaged in laboratory exercises that critically compared archival materials from audio-visual sources (Istituto Luce, Central State Archive) with contemporary examples of hate speech and ethnic and racial incitement. This comparative analysis highlighted the enduring patterns of prejudice and discrimination across different historical contexts.

Students in Rome embarked on a captivating journey through the archives of World War II, uncovering stories of betrayal, resilience, and the enduring impact of war. By engaging with primary sources, they transformed historical narratives into powerful dramatizations and multimedia productions. One group meticulously reconstructed the tragic tale of Giulio Levi, a young Roman Jew whose life was cut short by the treachery of his closest friends. Through their dramatization, they captured the devastating consequences of anti-Semitism and the human cost of collaborations. Another group turned their focus to the harrowing events of the Quadraro roundup, a mass arrest carried out by Nazi forces. Their poignant film interweaved archival footage with interviews conducted along the streets of today's Quadraro neighborhood, creating a powerful juxtaposition of past and present:
